Due to the volume of applications we receive, applicants who fail to send an updated application by that date, will unfortunately be removed from the waitlist.

#### SPECIAL EXCEPTION

Applications dated between March 31<sup>st</sup> and August 1<sup>st</sup>, will be kept on file until August 1<sup>st</sup> of the following year.  
An updated application is only required by August 1<sup>st</sup> of the following year.
